to be aware of the security measures to be taken for access and stay in the campsite, in order to prevent the risks of contagion and spread of COVID-19

to be aware of the obligation to immediately and responsibly inform the person in charge of the places (i.e. the Reception or the manager of the facility) of the onset of any flu symptoms while staying at the campsite and follow the instructions of the staff of the facility

to be aware of the obligation to maintain the interpersonal safety distance of at least one meter (distances that can be waived only by members of the same family or who stay in the same room) and to use personal protection tools.

to be aware that the use of supplied movable goods and access to common areas and services must be done in a quota manner, with a short parking time and with the maintenance of the interpersonal safety distance of at least one meter

INFORMATION PURSUANT TO ART. 13 OF REGULATION (EU) 2016/679 ("GDPR")

The company "The Three Musketeers" S.R.L. [NOTE: please check the list] - inform you that your personal data (hereinafter the "Data"), including the Health data - collected from you on the occasion of your entry at the respective headquarters and / o the respective camping village - will be processed for the sole purpose of preventing contagion from Covid-19, for the protection of workers' health and public health, in accordance with the applicable legislation as well as the protocols and guidelines issued by the authorities and associations sector-specific, including the "Shared protocol for the regulation of measures to combat and contain the spread of the Covid-19 virus in the workplace" (most recently updated on April 24, 2020). In this context, the aforementioned company (hereinafter the "Owner" or the "Company") acts as an independent data controller with reference to the personal data of the respective employees, collaborators, suppliers and guests who intend to access the relative offices and / or related campsites. The contact details of each company are available on the website www.tremoschettieri.com. The processing does not require your consent as it is necessary for the pursuit of the legitimate interest of the owner - pursuant to art. 6, c. 1, lett. f), of the GDPR - as well as for the fulfillment of the legal obligations to which the Data Controller is subject - pursuant to art. 6, c. 1, lett. c), and art. 9, c. 2, lett. b) of the GDPR - with particular reference to the obligations to implement the anti-contagion security protocols pursuant to the Prime Ministerial Decree of 11 March 2020 and subsequent legal provisions or regulations in force from time to time. The provision of data is necessary to fulfill the legal obligations identified above; therefore, the refusal to provide the Data will make it impossible for the Data Controller to allow you access to its offices and respective campsites.

Data will be kept, in general, for the period of time necessary to pursue the aforementioned purpose, also on the basis of the indications and provisions issued by the competent authorities, in any case not beyond the end of the state of emergency currently indicated on 31 July 2020 (resolution of the Council of Ministers of 31 January 2020) or as updated from time to time. The data relating to the detection of the temperature will not be recorded in any case, unless it is necessary to document the reasons that prevented access. The Data may be communicated to companies functionally responsible for carrying out the activities instrumental to the achievement of the aforementioned purpose, which will be appointed by the Data Controller, as well as to employees and / or collaborators of the Data Controller, who will be expressly designated as authorized persons. Furthermore, the Data may also be communicated to public authorities or law enforcement agencies (e.g. for the reconstruction of the supply chain of any close contacts of a subject tested positive to Covid-19), upon their request or to ascertain, exercise or defend one's own right. The Data will not in any case be disseminated or communicated outside the European Union. You can exercise the rights referred to in articles from 15 to 22 of the GDPR by contacting the Data Controller, writing to the address amministrazione@tremoschettieri.com. By way of example, you may: a) obtain access, rectification, cancellation of personal data or limitation of the processing of personal data concerning you or oppose their treatment; b) obtain the correction and integration of inaccurate or incomplete personal data; c) obtain data portability; d) propose a complaint to the Guarantor for the protection of personal data.
